Second Quarter Accomplishments

The second quarter of the year from April through June is traditionally one of our most active periods in terms of serving our members and making progress on our annual business plan. Shown below are just a few of our accomplishments:

- Led the community effort to celebrate Economic Development Week in coordination with our economic development partners, GJEP and BIC. A video that can be used to showcase how businesses can take advantage of the resources we offer to grow is now posted on the website.
- Defended the local business climate by legally challenging the Grand Valley Drainage District's fee assessment on businesses which resulted in individual businesses being billed in excess of \$8,000. The matter is still in the courts. Our argument is that this is a defacto tax and subject to a vote under the Taxpayer Bill of Rights.
- Graduated eleven new CEOs from the Young Entrepreneurs Academy ranging in age from 11 to 18. Each has launched a new business.
- Served as the business voice on over 39 pieces of legislation introduced in the Colorado General Assembly and published a scorecard of how our local delegation voted on bills of importance to the business community.
- Initiated business retention/expansion activities that resulted in visits to over 20 companies and the convening of two industry roundtables (technology and energy) that uncovered several expansion projects that have the potential for creation of over 250 jobs in the next 12-15 months.
- Led the opposition on the Western Slope of Colorado to Amendment 69, a ballot initiative aimed at creating a single payer health care system by taxing businesses which voters will decide in the fall election.
- Created the foundation for a new funding mechanism to underwrite Chamber business assistance programming known as the Total Resource Campaign.
- Hosted three Business After Hours events, three Networking at Noon sessions and assisted 12 companies in accessing big data to identify and market to customers through a partnership with the Mesa County Library.

Chairman's Column



Those of you that have read my column before may remember that I sometimes need a nudge from the Chamber staff reminding me that I need to write the next Chairman's Column and, unfortunately, they had to do it again today. But unlike previous months where we talk about what the topic should be, this month needed no discussion, as I knew exactly what it should cover. For me, June marks the half-way point of my time as your chairman and it is time to briefly reflect on what we have accomplished and take note of what there is still to do before Jeffrey Hurd becomes the next chairperson.

Looking back at previous topics covered in this column:

January was about how the Chamber is more than the board and staff, but about the members. Today as I attended the Quarterly Membership Lunch, I was reminded about how true this really is. We were able to acknowledge businesses that have added jobs and done capital improvements, as well as, celebrate all of the people in the room that are working to make Grand Junction a better place to live and work.

The February column was about how the over 100 members of the Governmental Affairs Committee take the time and effort to review what is happening on the local and state level so we may better understand the impact it will have on all of us. I am both happy and grateful to report that this committee is still going strong and actively engaged.

March was about economic development efforts and focused on the Listening to Business initiative. Your Chamber had its first roundtable in April and we are continuing to have them on a regular basis. This initiative makes sure that we are doing our best to meet the needs of the businesses in our community.

In April I wrote about leadership and the importance of such programs like the Young Entrepreneurs Academy (YEA!), The Leadership Class and the Young Professionals Network (YPN). Since then we celebrated the graduation of the YEA! students (everyone should go to the final presentations) and the 16 people that graduated from the Leadership Class. We are now in the process of accepting applications for both the next YEA! group and Leadership Class. These are great programs and I encourage as many people to participate as possible.

May was different, as the focus was on the litigation with the Grand Valley Drainage District. I do not have enough space in this column to recap all that has happened in any detail. The lawsuit and an injunction have been filed. The injunction is now under the discretion of the Judge and we are waiting on his ruling. As soon as a ruling is made, there will be a lot more communication from the Chamber.

Last month I was pleased to write about the Memorandum of Understanding (MOU) between your Chamber, Grand Junction Economic Partnership (GJEP) and The Business Incubator. This MOU better coordinated our economic development efforts and has had some immediate results. Economic efforts are more streamlined than ever and this has allowed the Chamber to help more local businesses even faster.

So what is next? The short answer is, a lot. In the coming months there will be a lot of discussion and work making sure Amendment 69 (Colorado State Health Care System Initiative AKA ColoradoCare) does not pass. We are launching a Total Resource Campaign to better listen and take action on what our members think are priorities, the annual golf tournament will be in September, The Business Showcase in October, industry round tables, a new Leadership Class, Business After Hours and much, much more. We are excited to be heading into the second half of 2016 strong and ready to serve our community.

Grand Valley Drainage District Lawsuit Update

The lawsuit filed by the Grand Junction Area Chamber and Mesa County challenging the legality of a new annual fee assessment by the Grand Valley Drainage District is now in the hands of District Court. Briefs have been filed by all parties to the original complaint, as well, as the request for an injunction.

We do not know when the Court will act to set a hearing or just rule on the injunction on the basis of the arguments already submitted. Regardless of the outcome of an injunction, which does require a higher standard, the Chamber remains confident that this case has merit and that ultimately the Drainage District erred in imposing this burden on businesses and residences without a vote. The Chamber will continue to keep its members updated on the case.

Ballot Issue Positions Taken by the Board

As many as 15 to 17 ballot issues will be voted on in Colorado this fall and many of them will have adverse impacts on businesses and the business climate. Conversely there are some ballot measures aimed at stemming this ballot overload which has resulted in our state constitution being more than double the length of the US constitution. Shown below are the ballot issues that the Chamber has considered so far. Several more are scheduled for the July Board Meeting.

- Amendment 69. Chamber Opposed.** Already certified for the ballot this measure would raise state taxes \$25 billion to create a new health care payment system for all individuals living in the state. A new governmental entity called Colorado Care would be created and funds along with benefits would be managed by a 21 member elected board that is not subject to recall. Funds would be generated from a payroll tax and a 10% income tax on small business owners and retirees who report more than social security income on their tax returns. The impact on economic development could be substantial.
- Amendment 96. Chamber Supported.** This amendment would require that any petition for a citizen-initiated constitutional amendment be required to have at least two percent of the registered electors who reside in each state senate district in order to be placed on the ballot. In addition, at least 55% of the votes cast are needed in order to pass a new constitutional amendment.
- Amendment 63. Chamber Opposed.** This amendment concerns a person's right to a healthy environment (including air, water, land and ecological systems) and requires state and local governments to assign the highest

priority to protecting the healthy environment. It also allows individuals to sue governmental entities to enforce this fundamental right. In essence any citizen could bring action against a local government to limit any business activity it deems a danger to their safety and right to a healthy environment.

- Amendment 75. Chamber Opposed.** This amendment to the constitution authorizes local governments to prohibit, limit or impose moratoriums on oil and gas development. It also authorizes local laws and regulations that are more restrictive than the state as a protection of a community's health, safety, welfare and environment.
- Amendment 78. Chamber Opposed.** This amendment is a new requirement on oil and gas development that requires a setback of 2500 s.f. from the nearest occupied structure or other specified or locally designated area. It has been estimated that as much as 90% of the land mass in the state could be impacted by this new requirement.
